- I understand that if I am unable to pay my tuition fees in line with the payment due date, Gateway Business College may cancel my enrolment.
- I understand that I am allowed to work a maximum of 40 hours per fortnight (with unlimited work-rights during semester breaks), these funds can be used to supplement my living costs but must not be my only source of income to pay my tuition fees and living expenses.
- I understand that my visa may be rejected or cancelled by the Department of Home Affairs (DHA) if it is determined that documents supporting my application are fraudulent or I have made a false declaration.
- I understand that if my visa application is rejected due to fraud I will not get any refund for fee deposited with Gateway Business College.
- I understand that my visa application will be rejected if DHA is not satisfied that I am a genuine student and or do not pass health and character checks.
- I full understand that if I decide to downgrade i.e. go to a course that has a lower AQF level I will not be released from Gateway Business College and will be required to apply for another visa.
